ITEM 4: On preliminary approval of a transaction related to the alienation of property constituting fixed assets, which purpose is the production, transmission, dispatching, distribution of electric and heat energy.

DECIDED TO:

Approve the transaction made by Rosseti South, PJSC, related to the alienation of property, which are fixed assets that are intended to produce, transmit, dispatch, distribute electrical and thermal energy, under an agreement for the gratuitous transfer of real estate owned by legal entities to the ownership of the municipal entiry "City of Azov" (hereinafter referred to as the Agreement), on the following essential terms:

- the composition of the alienated property in accordance with Appendix 3 hereto;
- the balance (residual) value of the property being alienated as of December 31, 2021 is 494,696 (Four hundred ninety-four thousand six hundred ninety-six) rubles 98 kopecks;
- the method of alienation of property is the gratuitous transfer of property to the ownership of the municipal entiry "City of Azov" of the Rostov Region under the Agreement;
 - Parties to the Agreement are:

Public Joint Stock Company Rosseti South (Transferring Party);

Municipal entity "City of Azov" (Receiving Party).

- Subject matter of the Agreement:

Pursuant the order of the Department of Property and Land Relations of the Administration of the City of Azov dated August 12, 2021, No. 279, "On the acceptance of real estate objects in the ownership of the municipal entity "City of Azov", the Transferring Party transfers to the ownership of the municipal entity "City of Azov" free of charge, and the Receiving Party takes ownership of the property titled as a gas boiler room, with an area of 9.7 sqm, Letter "D"; medium pressure gas pipeline, 23.5 m long, Letter "B", "B1", cadastral number 61:45:0000171:394, with the equipment included. The object is located in Russia, Rostov region, the city of Azov, Zoya Kosmodemyanskoy Avenue, 72v.

- the property transfer procedure:

The Transferring Party will transfer the object to the Receiving Party on the day of signing the Agreement under an acceptance certificate.

The Receiving Party acquires the right of ownership to the property acquired under the Agreement at the moment when the state registration authority for rights to real estate and transactions with it registers the ownership of the Receiving Party and makes an entry about the registration of the Receiving Party's right in the Unified State Register of Real Estate.

The Agreement is subject to registration with the Office of the Federal Service for State Registration, Cadastre and Cartography in the Rostov Region.
